This engagement does not include advice as to the conduct of affairs in the future. All taxpayers are advised, however, to maintain records of anything affecting tax returns for the last five years. NO INDEPENDENT VERIFICATION

Should data be provided that is misleading or false or otherwise incorrect, you agree to indemnify and hold harmless PK Tax Services, LLC from all resulting liability therefrom. Additionally, should information be submitted to PK Tax Services, LLC such that there is an unreasonable time to prepare and submit filings or returns, especially during the tax season, you understand that taxing authorities may impose certain penalties and/or interest which will be your responsibility.

All information you provide to us in connection with this engagement will be maintained by us on a strictly confidential basis. TERMINATION AND OTHER TERMS

We reserve the right to withdraw from this engagement without completing the returns if you fail to comply with the terms of this engagement letter. Upon such an event, all work performed to that point shall be billed and be due for payment by you upon receipt. If any portion of this agreement is deemed invalid or unenforceable, said finding shall not operate to invalidate the remainder of the terms set forth in this engagement. Additionally, if we, in our sole discretion, believe a conflict has arisen affecting our ability to service you and/or your business in accordance with either the ethical standards of our firm or the ethical standards of our profession, we may be required to suspend or terminate our services. Such an event would also be subject to this paragraph in its entirety.

FEES FOR THIS ENGAGEMENT

Our fee will be based upon our standard hourly rates, plus any out-of-pocket costs such as computer processing charges, long distance calls, postage, transportation, and travel. All fees are subject to the terms and conditions under this agreement; see Tax Fee Methodology for 2019. Estimated fees for this engagement will be based on your previous return pending any changes. With the new tax forms for 2018 and the new tax laws in effect for 2018 returns, fees may be \$50-\$100 higher than last year. If you are new, returns are typically in the range of \$300-\$600 for personal and \$475-\$775 for corporate. These are just estimates and can be more depending on your return and what is involved. Any unforeseen conditions such as incomplete accounting, missing documentation or changes in your tax circumstances that require additional labor hours or filings could cause the fee to exceed the estimate. Fees should be paid in full at time prior to efilg.

PAYMENTS, INTEREST & RELEASE OF INFORMATION

All fees and charges associated with this engagement are due upon your pick-up, our delivery or our submission of your return(s) and filing(s). Amounts remaining unpaid after 30 days, from such events bear interest of 1.5% compounded monthly. Should any balances be outstanding for services rendered before this engagement (“Outstanding Balances”) such Outstanding Balances must be paid in full (including associated interest that may have accrued) before: 1) any delivery or submission of your return(s) or filing(s) related to this agreement are made; or 2) any release of information, returns(s) or filing(s) related to this or prior engagements are provided to you or any third party you designate to receive such information, return(s) or filing(s).

COLLECTION

Should payment(s) for this engagement not be made within 90 days, or within another reasonably agreeable timeframe to PK Tax Services, LLC then any collection fees and/or attorney and court fees borne by PK Tax Services, LLC for the purposes of such collection will be paid by you in addition to the fees and interest quoted above. Should your business not be able to pay for services rendered, you personally agree to cover any and all such charges and obligations as set forth in this agreement.
